TUITION CONTRACT

The weekly rate for Summer Camp is \$50 per child, either in cash or money order. Payment is due for Week 1 at time of registration, for Week 2 on July 11, for Week 3 on July 18, and for Week 4 on July 25. A late fee of \$5 per day will be added to payments made the following Monday after the due date. If no payment is made a week after the due date, your child will not be able to attend the program until a payment is made.

I agree to pay \$50 per week, per child registered and understand they will be dismissed at 3:00pm.

I am unable to pay the \$50 amount per child and would like to speak to the director.

EXTENDED DAY

New City Kids has an additional Extended Day component to our summer camp. It will take place every day from 3:00 PM to 5:30 PM. It will include snack for the children and additional enrichment activities. This program runs on a first-come, first-served basis, and will cost an additional \$50 a week, totaling to \$100 per week per child.

I would like to enroll my child into the extended day program. I understand this program runs on a first-come first served basis. I agree to pay \$100 per week, per child.

I would like to enroll my child into the extended day program, but I am unable to pay the \$100 amount per child and would like to speak to the director.

URBAN LEAGUE

New City Kids accepts Urban League payments to fund your child's summer camp experience. Please be sure your contract is on file with the Urban League of Hudson County and will be current through the Summer Camp dates. If you are currently applying for Urban League you must still make cash payments until your agreement is settled. A refund will be issued once a contract is in place and swipes are up to date.

Parents must make daily swipes on the Urban League machine. Failure to swipe regularly after three days will result in a \$5 fee for each following day. If no swipe is made 5 days after an initial swipe, your child will not be able to attend the program until swipes are up to date.

I qualify for Urban League and will submit my contract before summer camp begins. I understand the information written above.

I do not qualify for Urban League and intend to pay through other means.

PARENT/GUARDIAN PERMISSION

Drop off and pick up

I give my child permission to attend New City Kids Summer Camp, Mondays-Fridays, July 9th - August 3rd. I am committing to having my child attend at least 3 weeks of camp. I understand that transportation is not provided and that children are to arrive no earlier than 8:30am and to be picked up at 3:00pm. I understand that my child will not be released to anyone other than the persons listed as authorized to pick up. For every 15 minutes that a child is in New City Kids' care after dismissal a \$10 late fee will be charged.

Field trips

I understand that one day per week, children will attend a field trip. Parents will be notified with details on each trip during the week. I understand that my signature on this permission slip allows my child to attend the field trips. Should I choose not to allow my child to attend a field trip, I will inform New City Kids staff and keep my child home on that day.

Photos

New City Kids staff occasionally takes pictures/videos of its programs and children. I give New City Kids permission to use these photographs or videos in its website or promotional materials such as brochures and flyers. If this is unacceptable, please submit a written letter stating your wishes for your child's photograph/video not to be used.

BEHAVIOR EXPECTATIONS/DISCIPLINE POLICY

We have a warm & loving environment at New City Kids & expect children to be respectful to staff & peers. In order to maintain a safe environment, we use the following discipline policy. The consequences for misbehavior are:

1. First incident – Verbal warning from teen or adult staff.*
2. Second incident – Time out in foyer, while meeting with adult staff to discuss the problem.*
3. Third incident – Time out in foyer, accompanied by a call home to parent or guardian.
4. Fourth incident – Suspension for a period of days to be decided by the Director.
5. Continued incidents – Removal from program.

*If the incident is serious enough, a staff member may proceed directly to Step 3 &/or 4 (particularly if the child's behavior endangers him/herself or others). I have read these parent permissions and the discipline policy and agree to these.
